DRIVING DIRECTIONS

If using a GPS, enter the address as 301 W. Fourth St. Dayton, OH
(Note: this is not an actual mailing address)

From Northbound I-75:

- Take Exit 53 (2nd, Salem, 1st) and stay in RIGHT hand lane.
- Road curves slightly and at the third traffic signal (Perry St) turn RIGHT.
- Go approx. 300 feet: TURN RIGHT into Lot C underground parking garage.

From Southbound I-75:

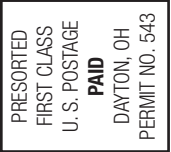
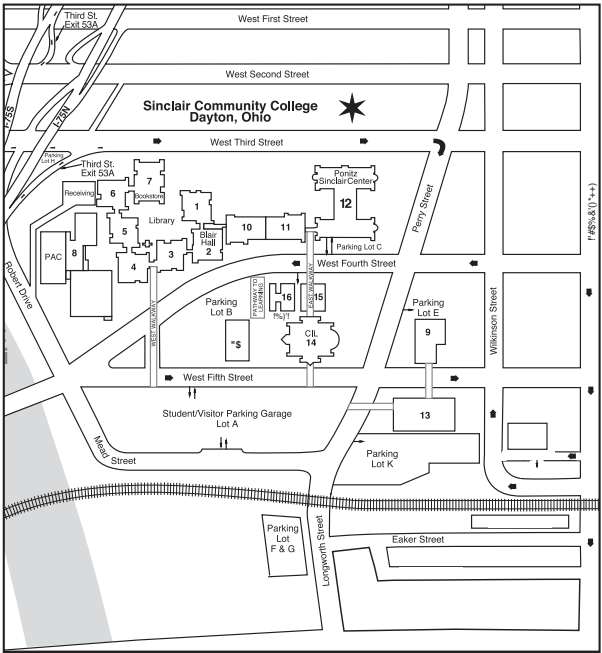
- Take Exit 53 (3rd, Salem) and stay in LEFT lane.
- Turn LEFT at the traffic signal (3rd St) and get in RIGHT lane.
- At the third traffic signal (Perry St) turn RIGHT.
- Next traffic signal is 4th St and turn RIGHT.
- Go approx. 300 feet: Turn RIGHT into Lot C underground parking garage.

From Westbound SR-35:

- Take I-75 Northbound to Exit 53 (2nd, Salem, 1st) and stay in RIGHT hand
- Road curves slightly, at third traffic signal (Perry St) turn RIGHT.
- Follow this to 4th St and turn RIGHT.
- Go approx. 300 feet: Turn RIGHT into Lot C underground parking garage.

From Eastbound SR-35:

- Take I-75 Southbound to Exit 51 (Edwin C. Moses Boulevard) stay in far LEFT lane, which circles back around to I-75 Northbound.
- Take Exit 53 (2nd, Salem, 1st) and stay in RIGHT hand lane.
- Road curves slightly and at the third traffic signal (Perry St) turn RIGHT.
- Follow this to 4th St and turn RIGHT.
- Go approx. 300 feet: Turn RIGHT into Lot C underground parking garage.
